WINE COUNTRY COWBOY DRESSAGE RELEASE, ASSUMPTION OF RISK, WAIVER AND INDEMNIFICATION

This document waives important legal rights, read it carefully before signing.

I AGREE in consideration for my participation in this competition, clinic or event to the following: **I AGREE** that I choose to participate voluntarily in the Competition, clinic or event with my horse, as a rider, driver, handler, lessee, owner, agent, coach, trainer, or as parent or guardian of a junior exhibitor. I am fully aware and acknowledge that horse sports and the Competition, clinic or event involve inherent dangerous risks of accident, loss, and serious bodily injury including broken bones, head injuries, trauma, pain, suffering, or death (“Harm”). **I AGREE** to release WINE COUNTRY COWBOY DRESSAGE and the Competition from all claims for money damages or otherwise from any Harm to me or my horse and for any Harm caused by me or my horse to others, even if the Harm resulted, directly or indirectly, from the negligence of WINE COUNTRY COWBOY DRESSAGE or the Competition, clinic or event. **I AGREE** to expressly assume all risks of Harm to me or my horse, including Harm resulting from the negligence of WINE COUNTRY COWBOY DRESSAGE or the Competition, clinic or event. I **AGREE** to indemnify (that is, to pay any losses, damages, or costs incurred by) WINE COUNTRY COWBOY DRESSAGE and the Competition, clinic or event and to hold them harmless with respect to claims of Harm to me or my horse, and for claims made by others for any Harm caused by me or my horse at the Competition, clinic or event. I have read the COWBOY DRESSAGE® Rules about protective equipment, and I understand that I am entitled to wear protective equipment without penalty (riders age 17 and under are required to wear protective head gear while mounted on show grounds) and I acknowledge that WINE COUNTRY COWBOY DRESSAGE strongly encourages me to do so while **WARNING** that no protective equipment can guard against all injuries. If I am a parent or guardian of a junior exhibitor, I consent to the child’s participation and **AGREE** to all of the above provisions and **AGREE** to assume all the obligations of this Release on the child’s behalf. **I AGREE** that WINE COUNTRY COWBOY DRESSAGE and Competition, clinic or event as used above includes all of their officials, officers, directors, employees, agents, personnel, volunteers and affiliated organizations including COWBOY DRESSAGE® WORLD LLC (DEBBIE AND EITAN BETH-HALACHMY, LYN RINGROSE MOE, AND GARN WALKER,) I represent that I have the requisite training, coaching and abilities to safely compete in this competition clinic or event. **BY SIGNING BELOW, I AGREE** to be bound by all applicable WINE COUNTRY COWBOY DRESSAGE Rules and all terms and provisions of this entry blank.
