**JACKPOT RAIL CLASS DESCRIPTION:** just as in riding a test, riders will perform the gaits at their level (W/J or W/J/L) along with a 4-6 step backup. Working and free gaits will be asked for. The judge may ask for a half turn on the haunches or forehand. Riders and horses are judged on soft feel, self carriage, balance, straightness, lightness, communication, and partnership. Money will be pooled from all participants, some retained by WCCD, and the rest is divided amongst top 3 riders in each category.

## RULES AND DISCLAIMERS

- Entries are not considered complete until entire form is completed including liability waiver and all entry fees are paid in full. WCCD has the right to refuse entry due to incomplete payment, lack of necessary signatures, poor conduct, safety concerns, or reaching maximum number of rides.
- **REFUNDS:** No refunds will be awarded within 2 weeks of show date unless accompanied by a veterinarian or physician’s note. Should a note be submitted, \$35 will be retained to cover secretary time and costs.
- **AWARDS:** Ribbons will be awarded 1st through 5th, along with 3 custom buckles for Overall Soft Feel, Open High Point, and Amateur/Junior High Point.
- **RIDE NUMBERS:** Maximum of four under saddle tests per horse (does NOT include rail class jackpots) will be enforced. Entries are accepted on a first-come first-serve basis. Ride times will be emailed and posted on website and Facebook before event.
- **CDW TESTS:** For Cowboy Dressage rules and tests visit [www.cowboydressageworld.com](http://www.cowboydressageworld.com). WCCD follows all guidelines laid out by Cowboy Dressage World and scores at our schooling shows do apply to those qualifying for CDW end of year high-point awards.
- **JACKPOT RAIL CLASSES:** just as in riding a test, riders will perform the gaits at their level (W/J or W/J/L) along with a 4-6 step backup. Working and free gaits will be asked for. The judge may ask for a half turn on the haunches or forehand. Riders and horses are judged on soft feel, self carriage, balance, straightness, lightness, communication, and partnership. **WINE COUNTRY COWBOY DRESSAGE RELEASE, ASSUMPTION OF RISK, WAIVER AND INDEMNIFICATION**

*This document waives important legal rights, read it carefully before signing.*

**I AGREE** in consideration for my participation in this competition, clinic or event to the following: **I AGREE** that I choose to participate voluntarily in the Competition, clinic or event with my horse, as a rider, driver, handler, lessee, owner, agent, coach, trainer, or as parent or guardian of a junior exhibitor. I am fully aware and acknowledge that horse sports and the Competition, clinic or event involve inherent dangerous risks of accident, loss, and serious bodily injury including broken bones, head injuries, trauma, pain, suffering, or death (“Harm”). **I AGREE** to release WINE COUNTRY COWBOY DRESSAGE and the Competition from all claims for money damages or otherwise from any Harm to me or my horse and for any Harm caused by me or my horse to others, even if the Harm resulted, directly or indirectly, from the negligence of WINE COUNTRY COWBOY DRESSAGE or the Competition, clinic or event. **I AGREE** to expressly assume all risks of Harm to me or my horse, including Harm resulting from the negligence of WINE COUNTRY COWBOY DRESSAGE or the Competition, clinic or event. I **AGREE** to indemnify (that is, to pay any losses, damages, or costs incurred by) WINE COUNTRY COWBOY DRESSAGE and the Competition, clinic or event and to hold them harmless with respect to claims of Harm to me or my horse, and for claims made by others for any Harm caused by me or my horse at the Competition, clinic or event. I have read the COWBOY DRESSAGE® Rules about protective equipment, and I understand that I am entitled to wear protective equipment without penalty (riders age 17 and under are required to wear protective head gear while mounted on show grounds) and I acknowledge that WINE COUNTRY COWBOY DRESSAGE strongly encourages me to do so while **WARNING** that no protective equipment can guard against all injuries.
