- \*\* Scribe and sitting time should be with a total of at least four judges.
- \_\_\_\_\_ Proof of 8 hours of Recommended Cowboy Dressage Judge shadow time. Please submit the CDW Shadow Time Form with totals, percentages and class placings.
  - \_\_\_\_\_ Letter of recommendation from show management for judging schooling show. To include number of rides judged. Scanned copies of up to 10 scored tests may be requested for review.

Fulfilling these requirements does not guarantee an approval to become a CDW Recommended Judge. The documents will be reviewed and the applicant will need to be approved by the Judge's Committee and the CDW Partners.
