Classes offered herein are covered by the rules and specifications designed by Cowboy Dressage World. The Owners, riders, and trainers are responsible for the knowledge of and compliance with the rules of Cowboy Dressage which can be found at [www.cowboyydressageworld.com](http://www.cowboyydressageworld.com).

**FREESTYLE** will only be held on Friday, August 7<sup>th</sup>. Classes will not begin before 1:00 p.m.

**FOOD:** There will be a food cart in the park.

**EXHIBITORS PARTY:** Saturday after the last class there will be an Exhibitors Party in the Pavilion! Bring your favorite dish to share. RSVP on Entry Form so we know how many people to expect. Bring your chair!

**AWARDS CEREMONY:** At the conclusion of the show, Sunday, August 9<sup>th</sup>, in the Pavilion, there will be an awards ceremony approximately 1 hour after the last class and scores have been tallied. We ask that all competitors stay until after the prize presentation is complete to help acknowledge their fellow riders.

**OUR HONORABLE JUDGES:** Jill Von Ilten and Additional Judge TBD.

**SUGGESTIONS:** Have something to say? Saw something you need to bring to our attention? Comment forms will be available at the show office. Please speak up and share your compliments and concerns.

**FREESTYLE:** Freestyle will be held Friday, August 7<sup>th</sup>. Classes will not begin before 1:00 p.m. Freestyle music needs to be formatted as mp3, copied onto a labeled USB flash drive, and be presented to the office for sound check by 10:00 a.m. Friday morning. Please have a note with instructions as to when music is to begin. Only one song and one rider on the thumb drive.

**CALLERS:** The rider is encouraged to memorize their tests. The use of a caller is not mandatory. Cowboy Dressage Gatherings allow the rider to use a caller of their choice, however, the ultimate responsibility for accurate and correct riding of the test falls upon the rider. If the rider chooses to use a caller, it is the rider's responsibility to arrange one.

**SPOTTER:** A spotter is allowed to walk next to a rider who could possibly become compromised during a test because of existing health conditions or a 10 and under rider. A spotter may not help or speak to a rider during the normal course of a ride (possibility of penalty at the discretion of the judge). However, if the rider is in distress, at that time, the Spotter will step in to help. The Spotter must sign a liability release at the Horse Show office before entering the show arena.

# Pacific Northwest Cowboy Dressage Gathering

## Awards & Prizes

We ask that all competitors stay until after the prize presentation is complete to help acknowledge their fellow riders. This Gathering is sanctioned by Cowboy Dressage® World.

### **RIBBONS:**

Classes will be placed first place through tenth place

Ribbons will be awarded first place through third place

Ribbon awards and tests will be available for pickup in the office after the scores for all the rides in that class are tallied. Please do not pick up any tests or ribbons other than your own.

### **RIDER STATUS DEFINITION:**

- **OPEN:** Rider that is 18 years or older, who makes a living or receives income from training, teaching lessons or clinics.
- **AMATEUR:** Nonprofessional rider that is 18 years or older
- **JUNIOR:** 17 and under (An individual who has not reached his/her 18<sup>th</sup> birthday as of January 1<sup>st</sup> of the current competition year). On show grounds, juniors are not allowed to handle/ride stallions and must wear a helmet when working with a horse at any time (not just while showing). A Junior Rider 10 years and under may have a spotter (see Spotter definition above).

### **SPECIAL SHOW-END AWARDS:**

- **HIGH SCORE BUCKLE:** Awarded to the highest average scoring rider/horse combination in Open, Amateur, and Junior. To be eligible, a rider/horse combination must show in a minimum of 4 classes at the show in any of the eligible classes. (Partnership, Freestyle and Horsemanship classes are not eligible to count towards the 4 classes). For calculations, the highest 4 scored tests will be added together and then divided by 4. Reserve high average score to be awarded as well, using the same method of calculation. Ties will be broken by the highest single soft feel score.
- **VAQUERO BUCKAROO HIGH SCORE BUCKLE (combined status):** Awarded to the highest average scoring rider/horse combination in Vaquero Buckaroo Division Classes. To be eligible, a rider/horse combination must show in a minimum of 4 classes in the Vaquero Buckaroo Division Classes. For calculations, the highest 4 scored tests will be added together and then divided by 4. Reserve high average score to be awarded as well, using the same method of calculation. Ties will be broken by the highest single soft feel score.
- **PARTNERSHIP HIGH SCORE BUCKLE:** Awarded to the highest average scoring rider/horse combination in Open, Amateur, and Junior Partnership Division Classes. To be eligible, a rider/horse combination must show in a minimum of 4 classes in the Partnership Division Classes. For calculations, the highest 4 scored tests will be added together and then divided by 4. Reserve high average score to be awarded as well, using the same method of calculation. Ties will be broken by the highest single soft feel score.
- **FREESTYLE HIGH SCORE RIBBON:** Awarded to the highest-scored test in Open, Amateur and Junior in the Freestyle Division. Rider/horse combination must show in a minimum of 4 eligible classes throughout the show. (Partnership, Freestyle and Horsemanship classes are not eligible to count towards the 4 classes). Ties will be broken by the highest single soft feel score.
- **HORSEMANSHIP HIGH SCORE RIBBON:** Awarded to the highest-scored test in the Horsemanship Division. Rider/horse combination must show in a minimum of 4 eligible classes throughout the show. (Partnership, Freestyle, and Horsemanship classes are not eligible to count towards the 4 classes). Ties will be broken by the highest single soft feel score.

- **SOFT FEEL BUCKLE:** Awarded to the highest soft feel score in Open, Amateur and Junior. Rider/horse combination must show in a minimum of 4 classes. (Partnership, Freestyle and Horsemanship classes are not eligible to count towards the 4 classes or their soft feel scores). Ties will be broken by the highest-scored test.
- **ROOKIE HIGH SCORE RIBBON:** Awarded to the highest-scored test for a first year Amateur Rider. Rider/horse combination must show in a minimum of 4 eligible classes throughout the show. (Partnership, Freestyle and Horsemanship classes are not eligible to count towards the 4 classes). Ties will be broken by the highest single soft feel score.
- **SILVER HIGH SCORE RIBBON:** Awarded to the highest-scored test for a 65+ year-old Amateur rider. Rider/horse combination must show in a minimum of 4 eligible classes throughout the show. (Partnership, Freestyle and Horsemanship classes are not eligible to count towards the 4 classes). Ties will be broken by the highest single soft feel score.
- **VETERAN HIGH SCORE RIBBON:** Awarded to the highest-scored test for a US veteran or anyone wishing to ride in honor of a US veteran. Rider/horse combination must show in a minimum of 4 eligible classes throughout the show. (Partnership, Freestyle and Horsemanship classes are not eligible to count towards the 4 classes). Ties will be broken by the highest single soft feel score.
- **CANCER HIGH SCORE RIBBON:** Awarded to the highest-scored test for any cancer survivor, anyone battling cancer, or anyone wishing to ride in honor of someone who has faced cancer may enter. Rider/horse combination must show in a minimum of 4 eligible classes throughout the show. (Partnership, Freestyle and Horsemanship classes are not eligible to count towards the 4 classes). Ties will be broken by the highest single soft feel score.
- **JACK BRAINARD JUDGE'S "TRY" AWARD RIBBON:** For the most improved rider for the duration of the show. To calculate this award, each judge identifies a horse/rider combination that showed marked improvement with each ride.

### **Cancellations and Refund Policy**

There will be no refunds for scratched tests after the entry closing date (7/24/26).

We encourage these options to cancellation in the event the horse or rider is unable to perform as planned:

- Classes entered may be revised up to one week before.
- Horse entered may be changed up to one week before.
- Rider may be changed up to one week before.

Partial refund may be granted as follows:

Any request for cancelation or refund must be submitted in writing, preferably email. Please include a veterinarian's or doctor's statement if applicable.

- Request for refund will be reviewed and approved after the event by a third party.
- Timing will play a part in approval of any fees as filling vacated entries will be considered in the refund review.

Any approved refunds will be processed within 30 days after the event.

- Once entry has been processed, there will be no refund of office fees, late entry fees or Cowboy Dressage World non-member fees.
- Class entry fees will not be eligible for refund unless there is a valid medical / veterinary condition, and/or the vacated class spot can be filled.
- Stall fees or Haul in fees may be refunded if horse is not on show grounds.
- Camping fees may be refunded if not used.
